TANECU Ltd

Tandahimba Newala Cooperative Union Ltd ('TANECU') was established in 2008. The activities of the union are:

- supervision of AMCOS: collection, storage & marketing, advertisements, purchasing bags and stationaries
- advice AMCOS in financial management, both board and staff
- connecting & providing agricultural inputs to AMCOS
- supervision of Cashew Nut Auction.

TANECU has 179 primary cooperative members, representing approximately 50.000 individual cashew nut farmers. TANECU employs 18 staff members. The board consists of eight members. The value that TANECU adds to the value chain is that it makes a connection between buyer and seller and it channels the money flowing back to the AMCOS. TANECU is able to maintain its position because the government has decided as such by law, i.e. only the cashew nut unions are allowed to market cashew nuts in Tanzania.

Background
