### Background of the assignment

The Farmer-Focused Transformation (FFT) programme is Agriterra's long-term approach to strengthening Farmer Organisations (FOs) as professional, business-oriented and influential actors in agricultural value chains. During FFT Phase 1 (2021–2025) in Côte d'Ivoire, Agriterra supported 15 FOs in cocoa and cashew, achieving measurable progress in governance, financial management, access to finance, market integration, processing initiatives, and inclusion of women and youth.

However, FFT1 also revealed important lessons:

- Not all cooperatives progress at the same pace or demonstrate the same entrepreneurial readiness;
- Business-led transformation (processing, service provision, investment finance) requires stronger institutional maturity than basic cooperative support;
- Strategic focus and milestone-based engagement are essential to avoid dependency and maximise impact.
- Building on these lessons, FFT Phase 2 (2026–2030) introduces a more selective, milestone-driven and investment-oriented approach.

FFT2 in Côte d'Ivoire will prioritise cooperatives that show clear ambition and capacity to:

- Operate as viable agricultural enterprises,
- Invest in cocoa processing and by-products,
- Develop sustainable service models for members,
- Mobilise internal and external capital, and
- Engage credibly with financial institutions, buyers, and public authorities.

For the phase 2 of FFT, Agriterra must objectively assess and classify cooperatives to determine which new FOs will be onboarded into FFT2,

Agripool experts will support Agriterra Côte d'Ivoire by conducting structured, independent cooperative assessments using Agriterra's proven frameworks. Their role is not to provide implementation support, but to bring peer-based judgement, financial and business expertise, and external objectivity into a critical decision-making phase.

By mobilising Agripool expertise, Agriterra ensures that FFT2 portfolio decisions are:

- Evidence-based and transparent,
- Aligned with donor expectations on efficiency and impact,
- Credible to financial and private-sector partners, and
- Anchored in Agriterra's unique value proposition of farmer-to-farmer and cooperative-to-cooperative learning.

This assessment process is therefore a foundational investment for FFT2, ensuring that the next phase builds directly on FFT1 achievements while avoiding duplication, dependency, or dilution of impact.

### Main objective

To support Agriterra Côte d'Ivoire in selecting high-potential, investment-ready Farmer Organisations for FFT Phase 2 through structured, independent cooperative assessments.

### Specific objectives

- Assess institutional maturity (governance, leadership, accountability)
- Analyse financial management systems and finance readiness
- Evaluate business ambition and feasibility (processing, services, markets)
- Assess capacity for internal capitalisation and external financing
- Classify FOs according to FFT2 pathways or exit/graduation options

### Expected results

Below are the expected results of the assignment:

1. Completed assessment reports for each FO visited
2. Clear scoring and classification aligned with FFT2 criteria
3. Practical recommendations for:
  - a. FFT2 implementation with the FO
4. Inputs to Agriterra's final FFT2 portfolio decision

### Assignment details
