TIDE Project

The Inclusive Dairy Enterprise project (TIDE) is an SNV dairy project in Southwest Uganda. It is funded by the Embassy of the Kingdom of the Netherlands (EKN) in Uganda for a 4-year period (till December 2019). The impact of this project is poverty reduction through improved dairy farm incomes, household nutrition and employment opportunities for 20,000 farmers. The project has four components to achieve its objectives:

1. Improved dairy farm productivity
2. Improved commercial milk quality
3. Improved pro-active dairy regulation
4. Improved dairy household nutrition

Objectives of the assignment
